I, Gehad Khaled Badawy, daughter of Mrs. Hoda Abdel Moneim Abdel Aziz — lawyer and former member of the National Council for Human Rights — submit this humanitarian appeal to Your Excellency, hoping that you will kindly consider my mother's situation and issue your orders for her release on health grounds or grant her a presidential pardon.

Over the past few weeks, I have closely followed Your Excellency's directives to pardon the citizen Alaa Abdel Fattah and his reunion with his family and son, which revived hope in all our hearts. From this same spirit of compassion and justice, I humbly appeal to Your Excellency to look into my mother's case, as she is now going through the most critical phase of her deteriorating health condition.

My mother was sentenced to five years in prison on charges of joining the Muslim Brotherhood in 2023. and even after serving the full sentence, which ended on October 31, she was kept in detention and included in two new cases with the same accusations — a matter that contradicts the principles of justice and doubles her suffering, as well as ours as a family.

Your Excellency,

My mother is 66 years old and suffers from severe chronic illnesses, including:

- Two consecutive heart attacks on August 23 and 30, 2025;
- Narrowing of the brain arteries, which left her bedridden for 12 consecutive days and caused temporary total paralysis;
- A chronic deep vein thrombosis (DVT) with pulmonary embolism, requiring precise and continuous treatment to prevent recurrence a condition posing an immediate threat to her life;
- Severe kidney deterioration, where the left kidney has completely stopped functioning, and there is regression in the right kidney, indicating imminent total kidney failure;
- A previous angina attack (chest pain due to heart ischemia) inside prison, amid ongoing health deterioration;
- Severe inflammation in her joints and spine, requiring urgent knee surgery followed by long-term medical care and rehabilitation.

Her continued detention under these conditions — especially after multiple heart attacks, worsening kidney function, and temporary paralysis — poses a grave and immediate risk to her life, and could, God forbid, lead to irreversible consequences.

Furthermore, she has not seen her grandchildren for many long years, and her only wish is to spend what remains of her life with her children and grandchildren, surrounded by her family, away from the pain and suffering of imprisonment.

Therefore, I respectfully and urgently appeal to Your Excellency — as her daughter — to grant her a presidential pardon or immediate release on medical grounds, giving her one final chance to live the rest of her days peacefully among her loved ones.
