REPORT ON LAWYERS' VIOLENT DEATH

2010 - MARCH 2015

LAWYERS' VIOLENT DEATHS

Around 18,000 lawyers are part of the Honduras Lawyers Association (CAH, by its initials in Spanish).

The Honduran State is obliged to guarantee, to lawyers, to do their work without any intimidation.

Furthermore, it is part of the authorities' duties to provide an adequate protection when physical integrity and Honduran lawyers' lives are threatened by the exercise of their profession.

Unfortunately, in Honduras, the practice of law has become a high-risk profession for those who practice it.

Summary of the facts occurred between 2010 and March, 2015

- I. The National Commissioner of Human Rights (CONADEH, by its initials in Spanish) registered between 2010 and March 2015, 89 cases of violent death against the same number of lawyers.
- II. During the administration of President Porfirio Lobo Sosa (2010- 2014), died in violently circumstances 76 lawyers, while so far the government of President

Juan Orlando Hernández 13 have died under those same circumstances (until March, 2015).

*Honduras has its political-geographical division on Departments, so the territory of the Republic of Honduras is divided in 18 Departments. F.M. is the abbreviation for the Department of Francisco Morazán, where is located the Honduras' capital, the Municipality of the Central District (M.D.C., by its initials in Spanish), conformed by two cities: Tegucigalpa and Comayagüela; the M.D.C. is informally known as Tegucigalpa. In the capital is where the highest incidence of murders against lawyers occurs.

The exercise of law has become a high-risk profession for those who practice primarily in the Departments of Francisco Morazán, which reported 34 dead lawyers violently; Cortés, 29; Yoro, 6; Atlántida, 5; Olancho, 4; Copán, 2; Comayagua, 2; Choluteca, 1, El Paraíso, 1; and, Colón, 5.

Of the 89 casualties reported by CONADEH: 72 (81%) were men and 17 (19%) were women.

IV. Among the lawyers who died violently in the past five years are included: former Judges of letters; Judges of Childhood; Specialists in Criminal Law, Labour Law, Commercial Law and Civil Law; Judges of Youth Persons; Judges of Vehicular Traffic; Judges for Criminal Matters; Judges of Peace (Judiciaries); and Judges and Magistrates of the Tribunal of Judgments.

They are also among the victims: Public Prosecutors working at the General Attorney's Office; Counsellors of several government agencies; Counsellors of peasant groups; Counsellors of trucking companies; Directors of the Lawyers' Bar of Honduras; Candidates aspiring to be elected for a public charge; pensioners, public defenders, lawyers who were practicing in private firms and others who combined their work with other business and religious activities.

V. Most of the victims were executed inside their vehicles, sometimes in the company of his children, wife, his worker, his driver, friends and even customers. Others were killed in their own home or a few steps of it and on public roads.

80 lawyers, representing 90%, were executed by firearms; 4 died from asphyxiation by strangulation; 1 for a supposed suicide; 3 were killed with knives; and one in which the perpetrators used fire guns and knives.

VII. In at least 5 cases the courts of justice have ruled against those responsible, however, 94% of all cases would be unpunished.

Violent incidents recorded in the last 27 months.

Between 2013 and March 2015, the National Commissioner of Human Rights (CONADEH) conducted a detailed register of each of the violent actions committed against legal professionals, with the following findings:

- I. CONADEH registered 45 violent acts against lawyers, leaving 40 people dead and ten wounded.
- II. Of the 40 killed people, 34 were lawyers and 6 individuals who were at the scene when the crime occurred.
- III. Of the 10 who were injured, 7 are lawyers, 1 employee of a law firm and the mother and the daughter of a legal professional.
- IV. Of the 34 professionals of law violently killed in the last 27 months, 28 were men and 6 women.
- V. Eight of the 18 Honduras' Departments were the scene of bloody events that killed of all these 34 lawyers: In the Department of Cortés 15 lawyers; 10 died violently at Francisco Morazán; 1 in Atlántida; 4 at Colón; 1 at Yoro, 1 at Olancho, 1 at Copán and 1 at Comayagua.

Death of lawyers in 2014

During 2014, the CONADEH registered the death of 11 lawyers, of which 8 were men and 3 women.

Six Departments were death scene for lawyers: 6 killed in Cortés, 1 in Atlántida, Colon 1, 1 in Comayagua, Olancho 1 and 1 in Francisco Morazán.

Of the 11 professionals of law killed, 2 were older adults aged 62 to 78 years. Most of the victims had their own law firms; in addition, one of them was serving as Coordinator of the Office of Common Crimes, and the other as Environmental Prosecutor, both were assigned in San Pedro Sula and killed in the same violent act. A public defender was murdered at Catacamas, a city of Department of Olancho. Also a former prosecutor died violently (at Tegucigalpa).

7 lawyers representing 64% died inside their vehicle when they were traveling; one when he was about to enter into his car; one when he was about to enter his home, 1 inside his property and 1 in the street.

In at least 82% of the cases, the or those people responsible for committing the crime were unknown people, in some cases, the police arrested the suspects involved in the killing of lawyers, however, they remain in impunity.

In 100% of deaths of lawyers, the perpetrators made use of firearms to execute the victims, in one case, also used white arms (knives).

Recommendations:

- 1. The CONADEH urges the Honduran authorities in charge of security in the country to take the necessary actions in order to make that the nearly hundred violent deaths against lawyers, registered in the last 63 months, does not enjoy impunity.
- 2. The government of the Republic is obliged to ensure that the Honduran lawyers perform their professional duties without any intimidation and even provide adequate protection especially when their physical integrity and life is at risk as a result of the exercise of their profession.
